

Proces Verbal of a Petit Jury Drawing

BE IT KNOWN AND REMEMBERED that on this 16th day of September, in the year of Our Lord, Two thousand Twenty-Five (2025),

Pursuant to law and in obedience of the Judicial Orders of the Judges of the 17th Judicial District Court, in and for the Parish of Lafourche, State of Louisiana, and in accordance with said order issued by Hon. Marla M. Abel, Division "C" Court, on July 12, 2024 on the Criminal Docket of the 17th Judicial District Court, duly and regularly cited to my attention,

I, Annette M. Fontana, Jury Commissioner and Clerk of said Court, sworn and qualified as such for the Parish aforesaid, met at the office of the Clerk of Court, and in the presence of Louie C. Leffingwell and Kiley M. Kliebert, two competent witnesses, disinterested and of lawful age, competent to read and write the English language, for the purpose, proceeded to draw, with the aid of a properly programmed computer, from the General Venire, indiscriminately, a Jury of 150 persons to be summoned to present for service on October 27, 2025, at 9:00 A.M., in Division "C" of this Court.





Juror Count: 150


