BE IT KNOWN AND REMEMBERED that on this 9th day of July in the year of Our Lord, Two thousand Twenty-Four (2024),

Pursuant to law and in obedience of the Judicial Orders of the Judges of the 17th Judicial District Court, in and for the Parish of Lafourche, State of Louisiana, and in accordance with said order issued by Hon. Christopher J. Boudreaux, Division “D” Court, on August 17, 2023, on the Criminal Docket of the 17th Judicial District Court, duly and regularly cited to my attention,

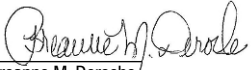

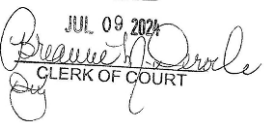
