Proces Verbal of a Petit Jury Drawing

BE IT KNOWN AND REMEMBERED that on this 3rd day of February in the year of Our Lord, Two Thousand Twenty-six (2026),

Pursuant to the law and in obedience of the Judicial Orders of the Judges of the 17th Judicial District Court, in and for the Parish of Lafourche, State of Louisiana, and in accordance with said order issued by Hon. Jennifer F. Richard, Division "B" Court, on August 11, 2025, on the Criminal Docket of the 17th Judicial District Court, duly and regularly cited to my attention,

I, Annette M. Fontana, Jury Commissioner and Clerk of said Court, sworn and qualified as such for the Parish aforesaid, met at the office of the Clerk of Court, and in the presence of Louie C. Leffingwell and Breanne M. 
Juror Count: 200
