The Town of Oak Grove proposes to upgrade its sewer system by employing the pipe bursting method to replace current gravity sewer mains. The project also includes the rehabilitation of lift stations, enhanc-

ing their functionality and longevity. Additionally, the town is conducting smoke testing and video inspections of existing gravity sewer mains to proactively identify and address potential issues. All work will be within the current footprint of the plant site or within existing right-of-way. No new right-of-way or land acquisition will be required for this project. There are no known environmentally sensitive areas and no Environmental Justice concerns associated with this project

This project will be funded, in part, through a grant made to the Town of Oak Grove by Sewer Overflow Grant (OSG) program and in part through a loan from the Clean Water State Revolving Fund (CWS-RF) program.
