The contract will be

awarded to the lowest

responsible bidder with-

out discrimination on

grounds of race, color,

sex or national origin.

Disadvantaged busi-

nesses will be afforded

full opportunity to submit

bids.

Plans and specifications

neer's office. Plans may

be obtained from the

District upon payment

of \$100. In accordance

with R.S. 38:2212(D),

deposits on the first set

of documents furnished

to bona fide prime bid-

ders will be fully refunded

upon return of the docu-

ments, deposits on any

additional sets will be

refunded less the actual

costs of reproduction.

Refunds will be made

upon return of the docu-

ments if within ten days

after receipt of bids.

The award of a contract,

if awarded, will be made

to the lowest qualified

bidder whose proposal

complies with all re-

quirements prescribed

within 45 calendar days

after opening proposals.

However, when the con-

tract is to be financed by

bonds which are required

to be sold after receipts

of bids, or when the con-

tract is to be financed in

whole or part by federal

or other funds not avail-

able at the time bids are

received, the time will not

start until receipt of fed-

eral and/or state concu-

rence or concurrence of

the other funding source.

Award will be within 30

calendar days after the

sale of bonds or receipt

of concurrence in award

from federal and/or state

agency or other funding

source. The successful

bidder will be notified

by letter mailed to the

address shown in the

proposal that the bidder

is awarded the contract.

The award of a contract

for projects financed ei-

ther partially or entirely

with State bonds will be

contingent on approval

by the State Bond Com-

mission.

On projects involving

federal funds the award

of contract will also be

contingent upon concu-

rence by the appropriate

state agency.

On projects involving

state funds the award

of contract will also be

contingent upon concu-

rence by the appropriate

state agency.

This right is reserved to

reject bids and waive in-

formalities.

stated in the Bidding

Documents shall not be

waived by any entity, per

LA R.S. 38§22.12.B(1)

as revised by ACT No.

759. Neither can any

or all bids be rejected,

other than for just cause
